The purpose of this document is to provide instructions on how to configure an IPsec VPN or SSL-VPN connection to your network from your Android device.

Licensing

VPN connections are free and no FortiClient license is required when connecting to a FortiGate unit running FortiOS v4.0 MR3 Patch Release 4 or later.

FortiClient v4.0 MR1 for Android supports Android OS v4.0.4 or later.

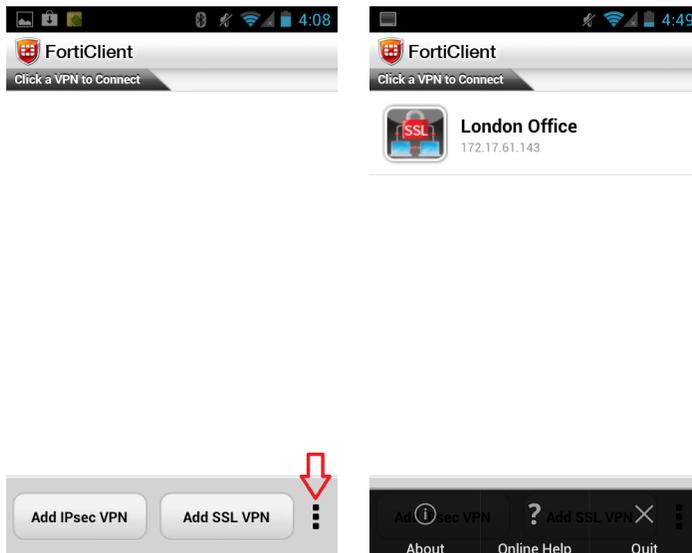

Figure 1: Options menu

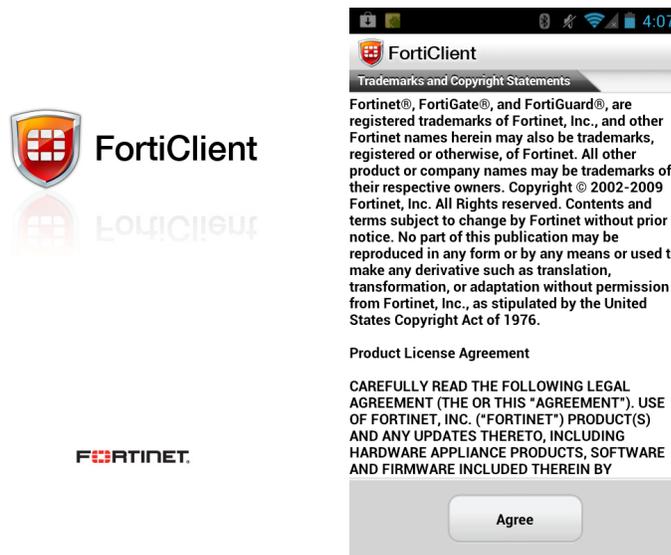


Open the Application

Open the application

Touch the FortiClient v4.0 MR1 for Android application icon on the Home screen or touch the application's icon on the Launcher. Read the Product License Agreement, and select *Agree* to continue.

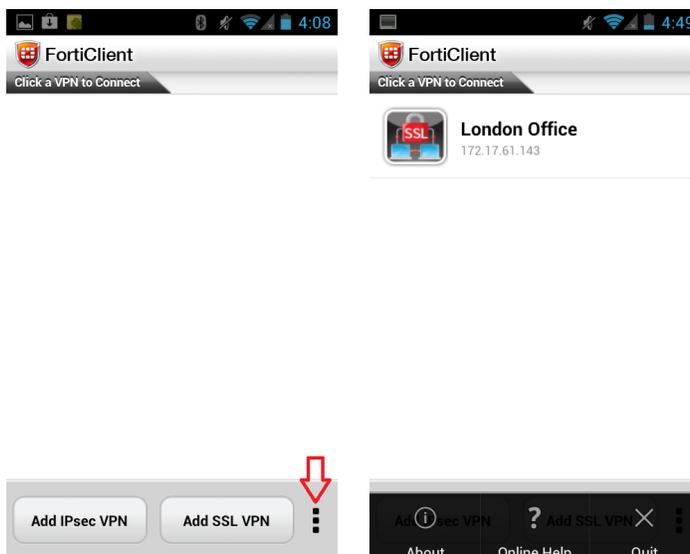
Figure 2: FortiClient launch screen and Product License Agreement

Figure 3: Options menu



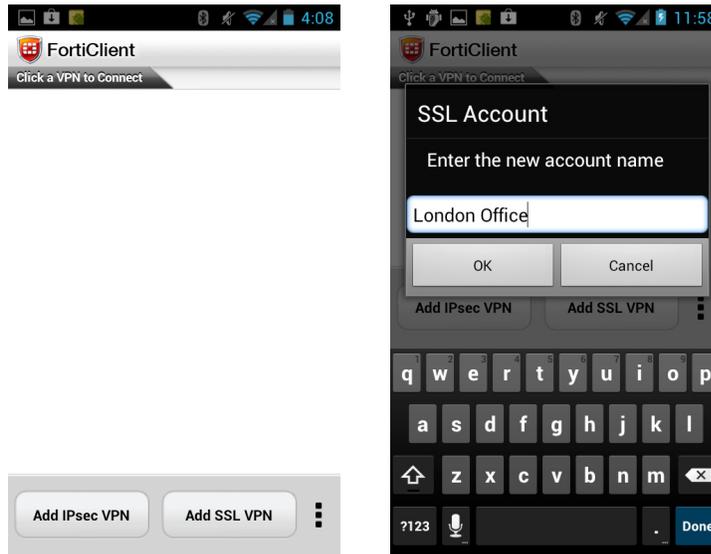
SSL-VPN

Create an SSL-VPN connection

To create a new SSL-VPN connection see the following steps.

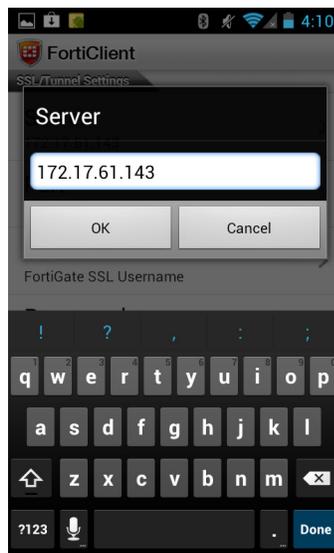
1. Touch *Add SSL-VPN* from the toolbar at the bottom of the page.
2. Enter the new account name for the SSL-VPN connection and touch *OK*.

Figure 4: Add SSL-VPN and SSL Account pages



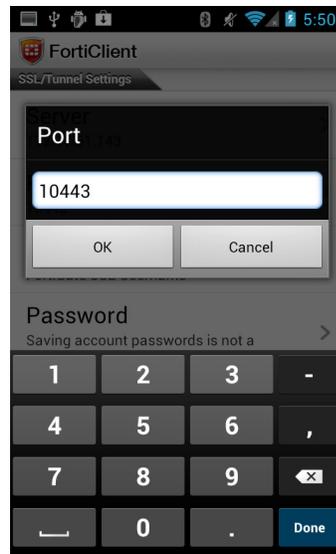
3. Touch *Server*, enter the server IP address and touch *OK*.

4. Touch *Port*, enter the port number, and touch *OK*. The default port is 10443.

Figure 6: Port setting page

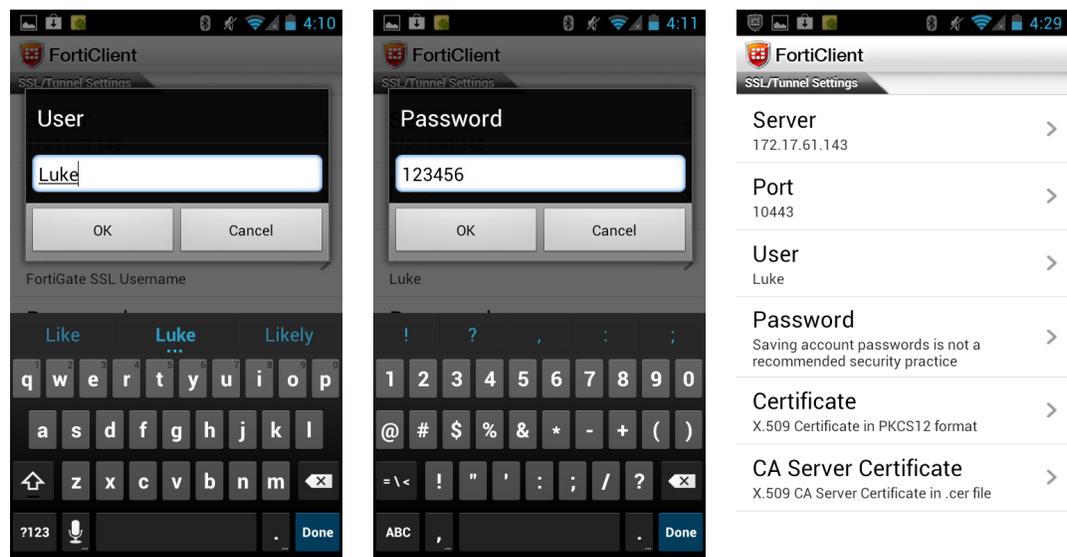


5. Touch *User*, enter a username, and touch *OK*.
6. Touch *Password*, enter a password, and touch *OK*. There is no maximum value for the password length. The password can consist of alpha, numeric and special characters.



The username and password configured on the client must match the username and password configured on the FortiGate. Contact your network administrator for the correct setting.

Figure 7: Username, password and main settings pages



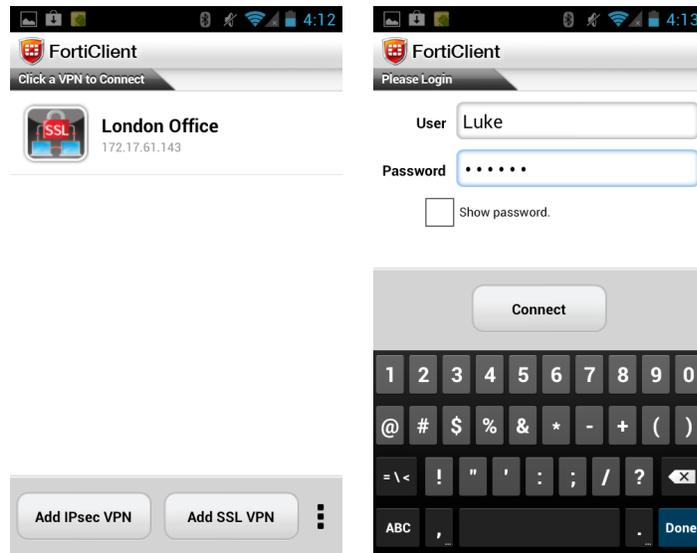
Connect to the VPN

SSL-VPN tunnel mode uses X.509 Certificates (PKCS12 format) for authentication. Certificate settings need to be configured if authentication requires the client certificate, otherwise leave the certificate settings as their default value. For more information see [Client and Server CA Certificates](#).

To connect to the SSL-VPN see the following steps.

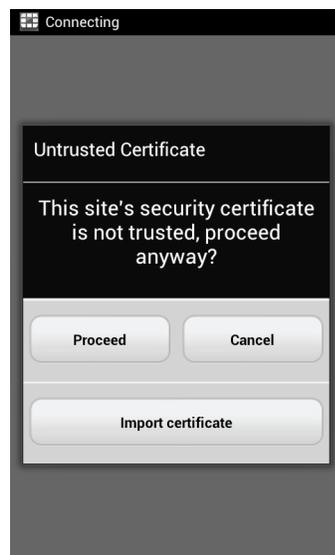
1. Touch an available *VPN* to connect.
2. Enter your username and password and touch *Connect*.

Figure 8: VPN connection, username and password pages



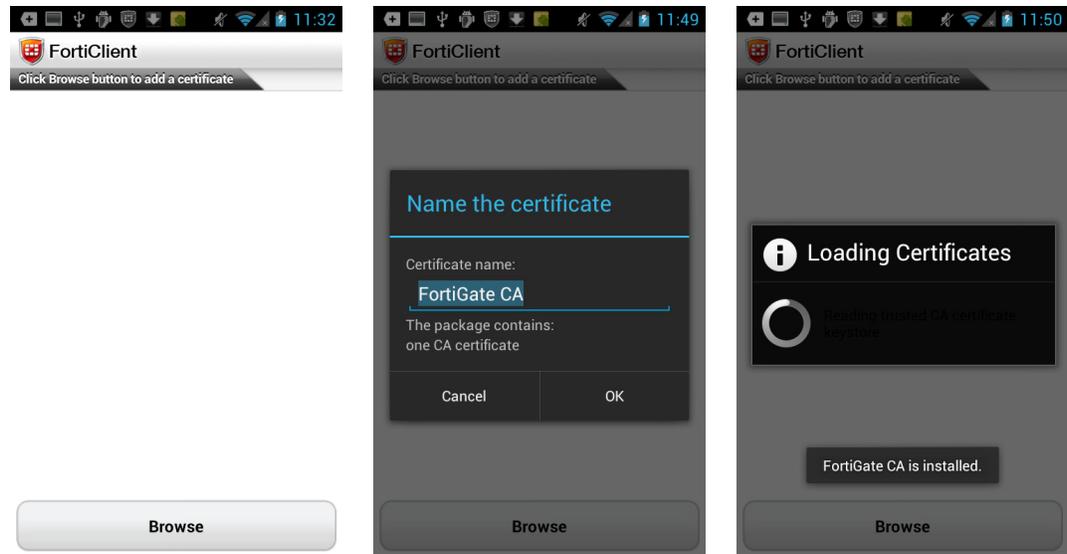
3. You will receive an *Untrusted Certificate* warning message, and you will have the option to *Proceed*, *Cancel*, or *Import certificate*.

Figure 9: Untrusted Certificate warning message



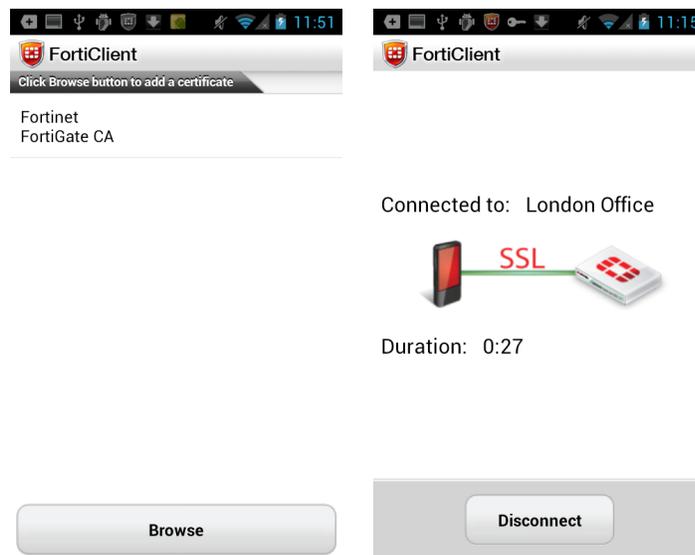
4. Touch *Import Certificate*, browse for the certificate file, edit the name (if required), and touch *OK* to load and install the certificate.

5. The certificate is now installed on the device. Use the device back button to return to the connection screen.
6. Touch an available VPN to connect.

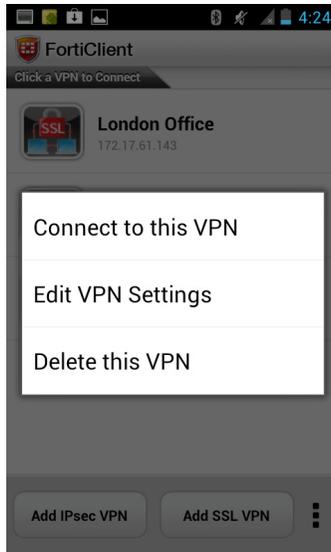
Figure 11: VPN connection pages

Figure 12:Edit VPN settings page



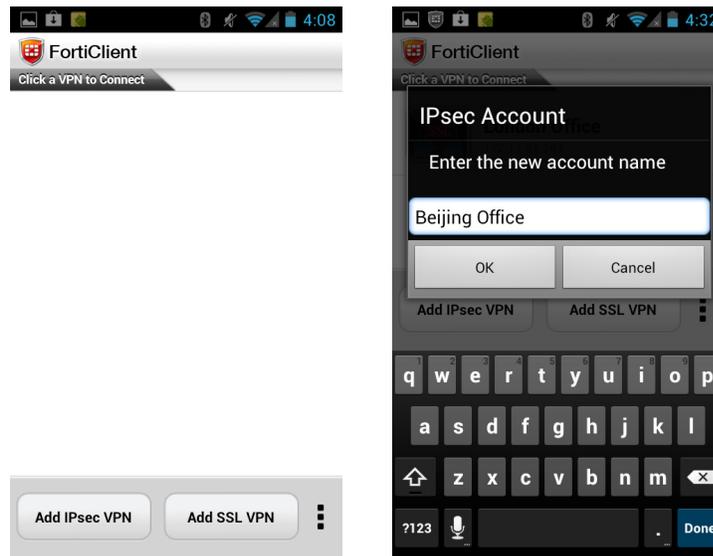
IPsec VPN

Create an IPsec VPN connection

To create a new IPsec VPN connection, see the following steps.

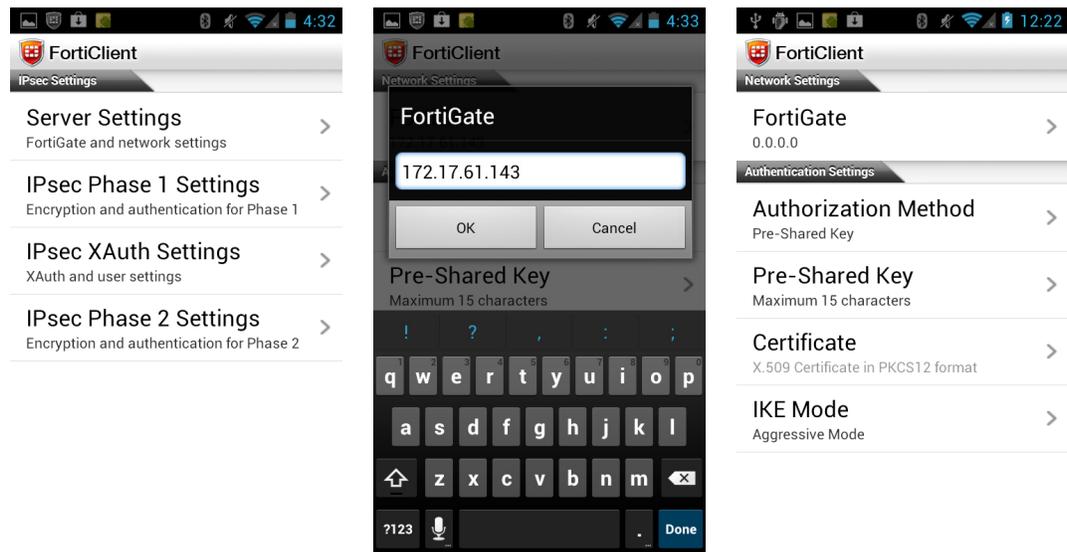
1. Touch *Add IPsec VPN* from the toolbar at the bottom of the page.
2. Enter the new account name for the IPsec VPN connection and touch *OK*.

3. Touch *Server Settings*, under *Network Settings*, touch *FortiGate*, enter the server IP address and touch *OK*.

Figure 14:IPsec Settings and Network Settings pages



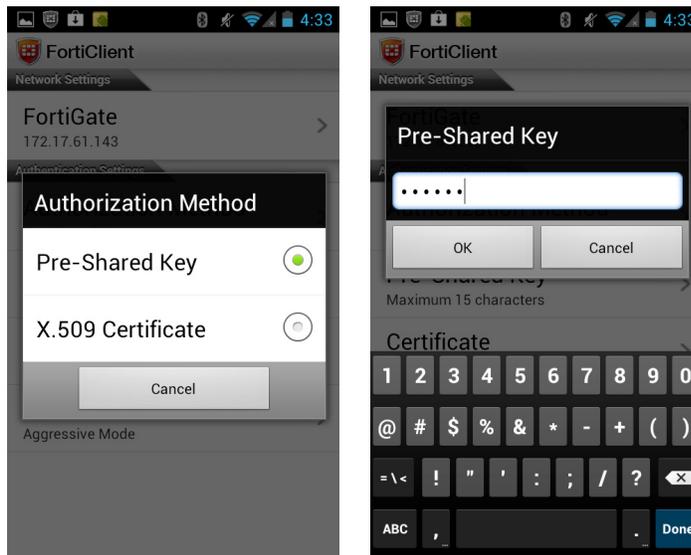
4. Under *Authentication Settings*, touch *Authorization Method* and touch either *Pre-shared key* or *X.509 certificate*.

- For pre-shared key, touch *Pre-shared Key* to enter the pre-shared key value.
The simplest way to authenticate with the FortiGate unit is by means of a pre-shared key. This is less secure than using certificates, especially if it is used alone, without requiring peer IDs or extended authentication (XAuth).
The pre-shared key must contain at least 6 printable characters. For optimum protection against currently known attacks, the key must consist of a minimum of 16 randomly chosen alphanumeric characters.



The pre-shared key configured on the client must match the pre-shared configured on the FortiGate. Contact your network administrator for the correct setting.

Figure 15:Pre-Shared Key page

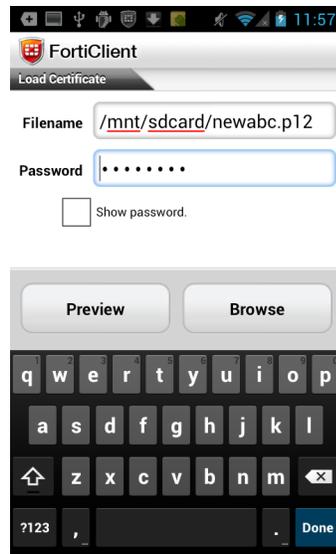


- For X.509 certificate, touch *Certificate*, and then browse for the certificate file on your device.
To authenticate with the FortiGate unit using digital certificates, you must have the required certificates installed on the android device (peer) and the FortiGate unit (server).

7. Touch *IKE Mode*, touch either *Aggressive Mode* or *Main Mode (ID protection)*.

In *Aggressive Mode*, the phase 1 parameters are exchanged in single message with authentication information that is not encrypted.

In *Main Mode*, the phase 1 parameters are exchanged in multiple rounds with encrypted authentication information.



The *IKE Mode* selected on the client must match the mode selected on the server. Contact your network administrator for the correct setting.

8. Use the device back button to return to the *IPsec Settings* page.
9. Touch *IPsec Phase 1 Settings* to view or edit the phase 1 proposal encryption and authentication settings. You can choose to use the default settings.

Select the encryption and authentication algorithms that will be used to generate keys for protecting negotiations. You can select any of the following symmetric-key algorithms:

- DES-Digital Encryption Standard, a 64-bit block algorithm that uses a 56-bit key.
- 3DES-Triple-DES, in which plain text is encrypted three times by three keys.
- AES128-A 128-bit block algorithm that uses a 128-bit key.

You can select one of the following message digests to check the authenticity of messages during phase 1 negotiations:

- MD5-Message Digest 5, the hash algorithm developed by RSA Data Security.
- SHA1-Secure Hash Algorithm 1, which produces a 160-bit message digest.

Select one or more Diffie-Hellman groups from DH group 1, 2, 5, and 14. When using aggressive mode, DH groups cannot be negotiated.

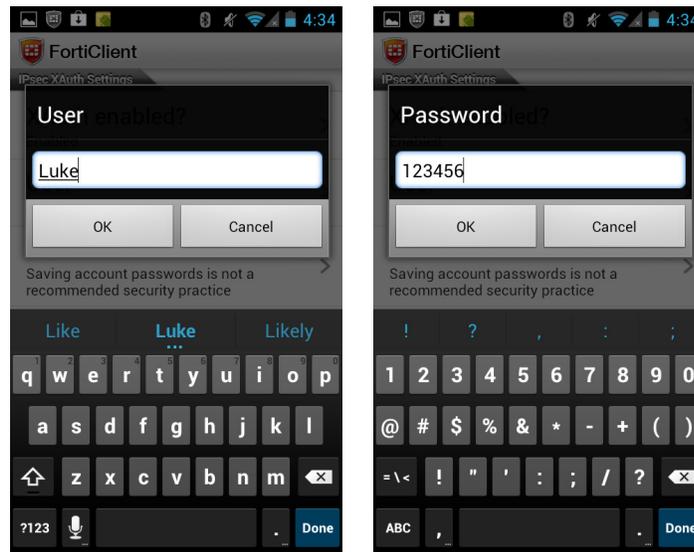


Contact your network administrator for the correct phase 1 encryption and authentication algorithms, and DH group.

10. Touch *IPsec XAuth Settings* to view or edit the XAuth and user settings. XAuth is enabled by default. Touch *User* to enter the FortiGate IPsec username. Touch *Password* to enter the password value. To use XAuth, you must first configure the user's credentials on your FortiGate, and external RADIUS or LDAP server.

Extended authentication (XAuth) increases security by requiring the remote dialup client user to authenticate in a separate exchange at the end of phase 1. XAuth draws on existing FortiGate user group definitions and uses established authentication mechanisms such as PAP, CHAP, RADIUS and LDAP to authenticate dialup clients.

11. Touch *IPsec Phase 2 Settings* to view or edit the phase 2 encryption and authentication settings. You can choose to use the default settings.

Select the encryption and authentication algorithms that will be used to generate keys for protecting negotiations. You can select any of the following symmetric-key algorithms:

- DES-Digital Encryption Standard, a 64-bit block algorithm that uses a 56-bit key.
- 3DES-Triple-DES, in which plain text is encrypted three times by three keys.
- AES128-A 128-bit block algorithm that uses a 128-bit key.

You can select one of the following message digests to check the authenticity of messages during phase 1 negotiations:

- MD5-Message Digest 5, the hash algorithm developed by RSA Data Security.
- SHA1-Secure Hash Algorithm 1, which produces a 160-bit message digest.

Select one or more Diffie-Hellman groups from DH group 1, 2, 5, and 14. When using aggressive mode, DH groups cannot be negotiated.

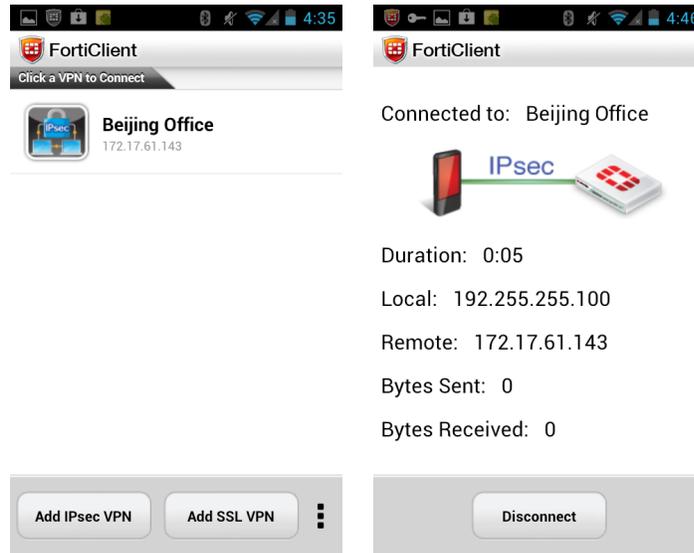

Figure 19:Edit VPN settings page



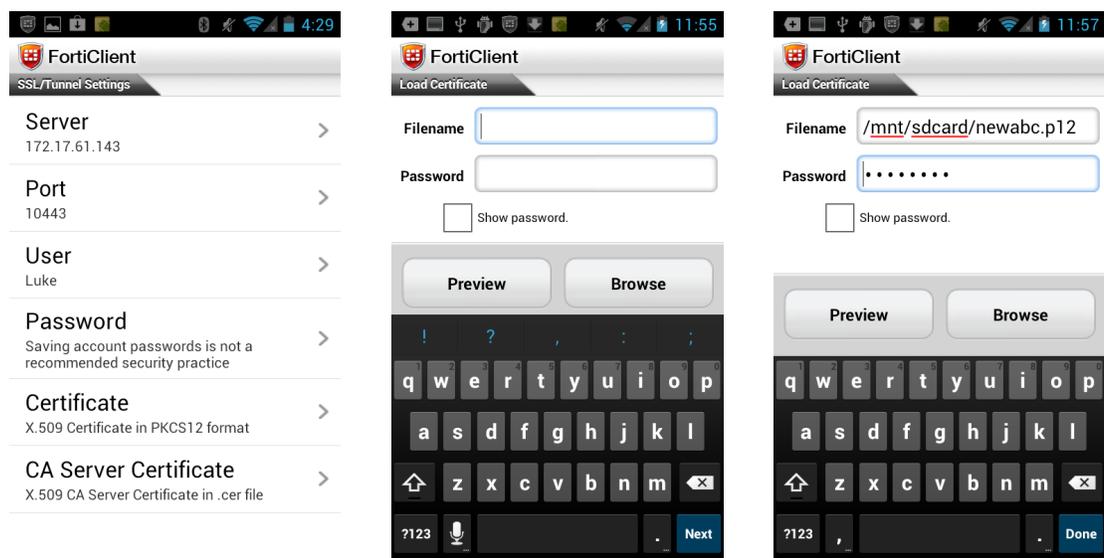
Client and Server CA Certificates

Client certificate

If the SSL-VPN connection requires a client certificate, the certificate needs to be imported to the device via the FortiClient application. The certificate needs to be in a PKCS12 format, and downloaded to the Android device first.

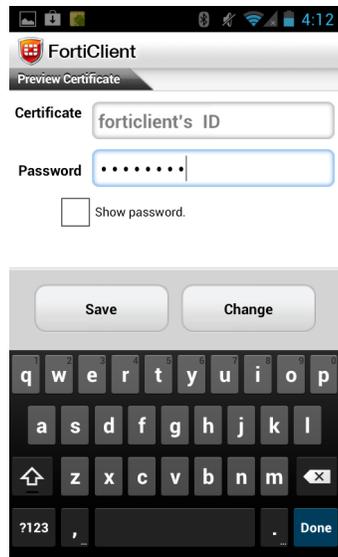
Select the > arrow next to the certificate from the SSL/Tunnel Settings screen. Select Browse, and locate the PKCS12 certificate from device storage, select Done to accept the file.

The certificate path will be visible under Filename, enter the Password, and select Preview. The certificate field is populated with the certificate name. Select Save to load the certificate.

Figure 21:Preview Certificate page

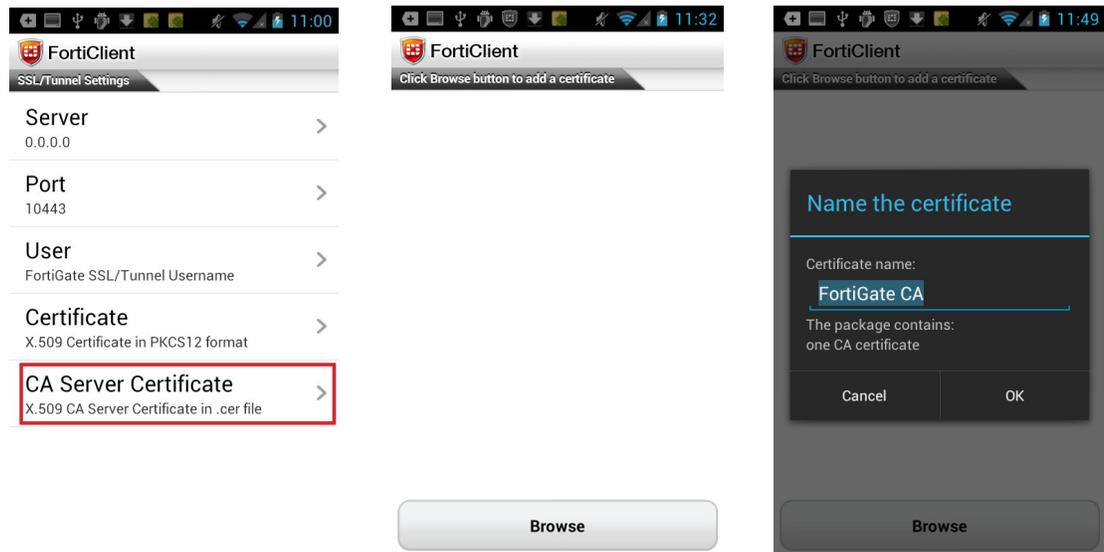


CA certificate

If the server certificate is not signed by a trusted root certificate authority, then the CA certificate needs to be imported to the device via the FortiClient application.

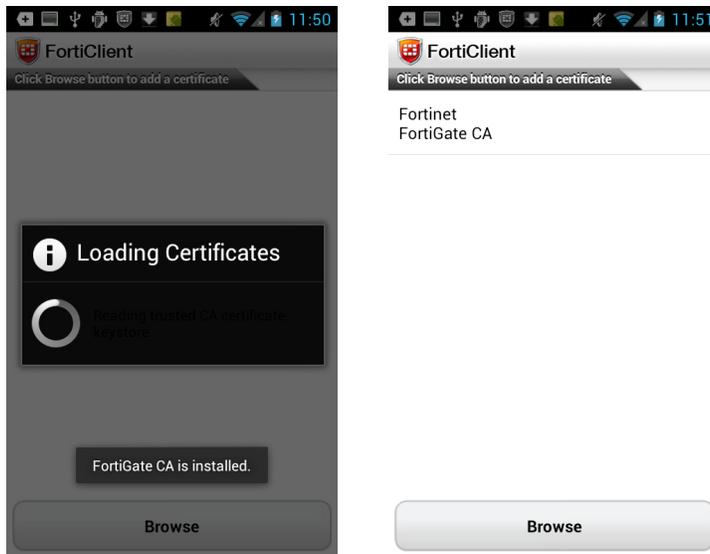
Select the > arrow next to the certificate from the SSL/Tunnel Settings screen. Select Browse, and locate the .cer format certificate from device storage. Select the certificate file, edit the name (if required), and select OK to load and install the certificate.

Figure 22:SSL/Tunnel Settings and certificate pages



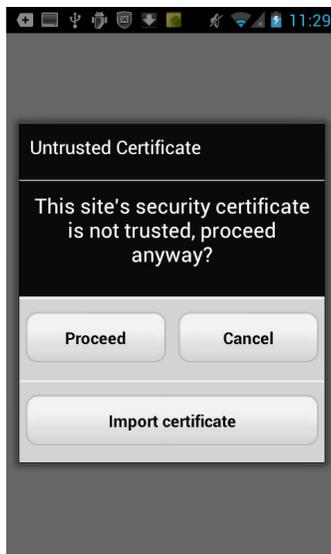
Once the file is successfully loaded, the CA certificate summary is displayed.

Product License Agreement

FORTINET SHALL NOT BE BOUND BY ANY ADDITIONAL AND/OR CONFLICTING PROVISIONS IN ANY ORDER, RELEASE, ACCEPTANCE OR OTHER WRITTEN CORRESPONDENCE OR OTHER WRITTEN OR VERBAL COMMUNICATION UNLESS EXPRESSLY AGREED TO IN A WRITING SIGNED BY THE GENERAL COUNSEL OF FORTINET. 1. License Grant.

This is a license, not a sales agreement, between you and Fortinet. The term “Software”, as used throughout this Agreement, includes all Fortinet and third party firmware and software provided to you with, or incorporated into, Fortinet appliances and any stand-alone software provided to you by Fortinet, with the exception of any open source software contained in Fortinet’s Products which is discussed in detail in section 15 below, and the term “Software” includes any accompanying documentation, any updates and enhancements of the software or firmware provided to you by Fortinet, at its option. Subject to proper payment to Fortinet and your compliance with the other terms and conditions, Fortinet grants to you a non-transferable (except as provided in section 5 (“Transfer”) and section 13 (“Open Source Software”) below), non-exclusive license to use the Software solely for your internal business purposes, in accordance with the terms set forth in this Agreement and subject to any further restrictions in Fortinet documentation, and solely on the Fortinet appliance, or, in the case of blades, CPUs or databases, on the single blade, CPU or database on which Fortinet installed the Software or, for stand-alone Software, solely on a single computer running a validly licensed copy of the operating system for which the Software was designed, or, in the case of blades, CPUs or databases, on a single blade, CPU or database. For clarity, notwithstanding anything to the contrary, all licenses of Software to be installed on blades, CPUs or databases are licensed on a per single blade, solely for one blade and not for multiple blades that may be installed in a chassis, per single CPU or per single database basis, as applicable. The Software is “in use” on any Fortinet appliances when it is loaded into temporary memory (i.e. RAM). Note that, for evaluation or beta Products for which Fortinet does not charge a fee, the payment requirement does not apply and the Product is provided to you as-is and you are not entitled to any warranty, under section 6 (“Limited Warranty”) below or otherwise. You agree that, except for the limited, specific license rights granted in this section 1, you receive no license rights to the Software.

2. Limitation on Use.

You may not attempt to, and, if you are a corporation, you are responsible to prevent your employees and contractors from attempting to, (a) modify, translate, reverse engineer,

decompile, disassemble, create derivative works based on, sublicense, or distribute the Software; (b) rent or lease any rights in the Software in any form to any third party or make the Software available or accessible to third parties in any other manner; (c) except as provided in section 5, transfer assign or sublicense right to any other person or entity, or (d) remove any proprietary notice, labels, or marks on the Software, Products, and containers.

3. Proprietary Rights.

All rights, title, interest, and all copyrights to the Software and any copy made thereof by you and to any Product remain with Fortinet. You acknowledge that no title to the intellectual property in the Software or other Products is transferred to you and you will not acquire any rights to the Software or other Products except for the specific license as expressly set forth in section 1 (“License Grant”) above.

4. Term and Termination.

Except for evaluation and beta licenses or other licenses where the term of the license is limited per the evaluation/beta or other agreement, the term of the license is for the duration of Fortinet’s copyright in the Software. Fortinet may terminate this Agreement, and the licenses and other rights herein, immediately without notice if you breach or fail to comply with any of the terms and conditions of this Agreement. You agree that, upon such termination, you will cease using the Software and any Product and either destroy all copies of the Fortinet documentation or return all materials to Fortinet. The provisions of this Agreement, other than the license granted in section 1 (“License Grant”), shall survive termination.

5. Transfer.

If you are a Fortinet contracted and authorized reseller or distributor of Products, you may transfer (not rent or lease unless specifically agreed to in writing by Fortinet) the Software to one end user on a permanent basis, provided that: (i) you ensure that your customer and the end user receives a copy of this Agreement, is bound by its terms and conditions, and, by selling the Product or Software, you hereby agree to enforce the terms in this Agreement against such end user, (ii) you at all times comply with all applicable United States export control laws and regulations, and (iii) you agree to refund any fees paid to you by an end user who purchased Product(s) from you but does not agree to the terms contained in this EULA and therefore wishes to return the Product(s) as provided for in this Agreement.

6. Limited Warranty.

Fortinet provides this limited warranty for its product only to the single end-user person or entity that originally purchased the Product from Fortinet or its authorized reseller or distributor and paid for such Product. The warranty is only valid for Products which are registered on Fortinet’s Support Website: <https://support.fortinet.com>. For the below software warranty to start, registration must take place within three hundred sixty-five (365) days from the date the Product was originally shipped from Fortinet’s facilities or the warranty is null and void and will not be honored. For the hardware warranty, such warranty starts on the earlier of the date of Product registration on Fortinet’s Support Website or ninety (90) days from the date that the Product was originally shipped from Fortinet’s facilities. It is the Fortinet distributor’s and reseller’s responsibility to make clear to the end user the date the product was originally shipped from Fortinet, and it is the end user’s responsibility to understand the original ship date from the party from which the end user purchased the product. All warranty claims must be submitted in writing to Fortinet before the expiration of the warranty term or such claims are waived in full, i.e. ninety (90) days from the earlier of registration or the automatically started term for hardware and spare parts claims and three hundred sixty-five (365) days from registration within three hundred sixty-five (365) days from shipment for software claims. Fortinet provides no warranty for any beta or evaluation Products, for any spare parts not purchased directly from Fortinet by the end-user, for any accessories, or for any stand-alone software.

Fortinet warrants that the hardware portion of the Products, including spare parts unless noted otherwise (“Hardware”) will be free from material defects in workmanship as compared to the functional specifications for the period set forth as follows and applicable to the Product type (“Hardware Warranty Period”): a three hundred sixty-five (365) day limited warranty for the Hardware excluding spare parts, and, for spare parts, solely a ninety (90) days limited warranty. Fortinet’s sole obligation shall be to repair or replace the defective Hardware at no charge to the original owner. This obligation is exclusive of transport fees, labor or installation costs, and any other cost which are not directly associated to the Product. Such repair or replacement will be rendered by Fortinet at an authorized Fortinet service facility as determined by Fortinet. The replacement Hardware need not be new or of an identical make, model, or part; Fortinet may, in its discretion, replace the defective Hardware (or any part thereof) with any reconditioned Product that Fortinet reasonably determines is substantially equivalent (or superior) in all material respects to the defective Hardware. The Hardware Warranty Period for the repaired or replacement Hardware shall be for the greater of the remaining Hardware Warranty Period or ninety days from the delivery of the repaired or replacement Hardware. If Fortinet determines in its reasonable discretion that a material defect is incapable of correction or that it is not practical to repair or replace defective Hardware, the price paid by the original purchaser for the defective Hardware will be refunded by Fortinet upon return to Fortinet of the defective Hardware. All Hardware (or part thereof) that is replaced by Fortinet, or for which the purchase price is refunded, shall become the property of Fortinet upon replacement or refund.

90-day Software Warranty: Fortinet warrants that the software portion of Hardware Products will substantially conform to Fortinet’s then current functional specifications for the Software, as set forth in the applicable documentation for a period of ninety (90) days (“Software Warranty Period”), if the Software is properly installed on approved Hardware and operated as contemplated in its documentation. Fortinet’s sole obligation shall be to repair or replace the non-conforming Software with software that substantially conforms to Fortinet’s functional specifications. Except as otherwise agreed by Fortinet in writing, the replacement Software is provided only to the original licensee, and is subject to the terms and conditions of the license granted by Fortinet for the Software. The Software Warranty Period shall extend for an additional ninety (90) days after any replacement software is delivered. If Fortinet determines in its reasonable discretion that a material non-conformance is incapable of correction or that it is not practical to repair or replace the non-conforming Software, the price paid by the original licensee for the non-conforming Software will be refunded by Fortinet; provided that the non-conforming Software (and all copies thereof) is first returned to Fortinet. The license granted respecting any Software for which a refund is given automatically terminates immediately upon refund. For purpose of the above hardware and software warranties, the term “functional specifications” means solely those specifications authorized and published by Fortinet that expressly state in such specifications that they are the functional specifications referred to in this section 6 of this Agreement, and, in the event no such specifications are provided to you with the Software or Hardware, there shall be no warranty on such Software.

7. Disclaimer of Other Warranties and Restrictions.

EXCEPT FOR THE LIMITED WARRANTY SPECIFIED IN SECTION 6 ABOVE, THE PRODUCT AND SOFTWARE ARE PROVIDED “AS-IS” WITHOUT ANY WARRANTY OF ANY KIND INCLUDING, WITHOUT LIMITATION, ANY IMPLIED WARRANTY, IMPLIED OR EXPRESS WARRANTY OF MERCHANTABILITY, OR WARRANTY FOR FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. IF ANY IMPLIED WARRANTY CANNOT BE DISCLAIMED IN ANY TERRITORY WHERE A PRODUCT IS SOLD, THE DURATION OF SUCH IMPLIED WARRANTY SHALL BE LIMITED TO NINETY (90) DAYS FROM THE DATE OF ORIGINAL SHIPMENT FROM FORTINET. EXCEPT AS EXPRESSLY COVERED UNDER THE LIMITED WARRANTY PROVIDED HEREIN, THE ENTIRE RISK AS TO THE QUALITY, SELECTION AND PERFORMANCE OF THE PRODUCT IS WITH THE PURCHASER OF THE PRODUCT. NOTWITHSTANDING ANYTHING TO THE CONTRARY, THE HARDWARE WARRANTY PERIOD DISCUSSED ABOVE DOES NOT APPLY TO CERTAIN FORTINET PRODUCTS, INCLUDING FORTIFONE WHICH HAS A NINETY (90) DAY LIMITED WARRANTY

AND THE SOFTWARE WARRANTY DOES NOT APPLY TO CERTAIN FORTINET PRODUCTS, INCLUDING FortiWifi-ONE AND VDOM SOFTWARE.

The warranty in Section 6 above does not apply if the Software, Product or any other equipment upon which the Software is authorized to be used (a) has been altered, except by Fortinet or its authorized representative, (b) has not been installed, operated, repaired, or maintained in accordance with instructions supplied by Fortinet, (c) has been subjected to abnormal physical or electrical stress, misuse, negligence, or accident; or (d) is licensed for beta, evaluation, testing or demonstration purposes or for which Fortinet does not charge a purchase price or license fee. In the case of beta, testing, evaluation or free Software or Product, the end user acknowledges and agrees that such Software or Product may contain bugs or errors and could cause system failures, data loss and other issues, and the end user agrees that such Software or Product is provided “as-is” without any warranty whatsoever, and Fortinet disclaims any warranty or liability whatsoever. 8. Governing Law.

This Agreement and the warranty herein shall be governed by the laws of the state of California, without regards to the conflicts of laws principles thereof. In all events the terms of this Agreement and the limitations of liability, disclaimers of warranties and other restrictions herein shall be enforced to the maximum extent permissible by applicable law.

9. Limitation of Liability.

b) Give prominent notice with the combined library of the fact that part of it is a work based on the Library, and explaining where to find the accompanying uncombined form of the same work.
